MEMORANDUM OF CANCELLATION


Shri **RAKESH KUMAR SARAN** (Roll No.- 2404008040, Rank-SL/III/01418), candidate belonging to SSC NR Region, was recommended for appointment as Inspector (Preventive Officer) on the basis of result of **Combined Graduate Level Examination-2019** and allotted to Mumbai Customs Zone by Central Board of Indirect Taxes and Customs.

After completion of Pre Appointment formalities i.e. Medical Examination, Physical Standard Test and Document Verification, Offer of Appointment was issued to the candidate on 22.10.2022 with a direction to report on duty on or before 18.11.2022. Further, extensions in joining were also granted till 21.04.2023 by the competent authority. However, the candidate hadn't approached to join the duties as Inspector (Preventive Officer).

Thus, the offer of appointment has lapsed after completion of six months period from the date of issue of Original Offer of Appointment as per DoPT O.M. No. 35015/2/93-Estt.(D) dated 09.08.1995.

In view of the above, the candidature of Shri **RAKESH KUMAR SARAN**, is henceforth cancelled and his dossier is being returned to the Staff Selection Commission and no representation in this regard will be entertained by this office in future.
