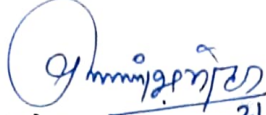
2. If the transferred officers retain the present place of posting despite such orders and fail to join within 02 weeks of the orders, vigilance section of this zone may initiate disciplinary action under CCS Conduct Rule 1964 and P&E Section, NCH, Zone-I may undertake stoppage of salary benefits also.

3. It has been directed by the Competent Authority that the respective Controlling Officers shall ensure that all the officers are relieved by the above specified instructions and send a consolidated report of relieved and joined officers to the O/o the Deputy Commissioner of Customs, P&E, Mumbai Customs Zone-I by **03.03.2023.**
