In pursuance of Boards letter F. No. A-12018/02/2017-AD.IIIB dated 19.02.2026, it is proposed to fill up some regular posts in the grade of Inspector (Preventive Officer) in the pay matrix Level 7 (Rs 44,900-1,42,400) for the vacancy year 2026 (from 01.01.2026 to 31.12.2026) by way of One Time Relaxation in Recruitment Rules for the post of Inspector (Preventive Officer).

2. Therefore, willingness is called for from Executive Assistants (EAs)/ Stenographers Grade-I who have rendered minimum 02 years and 06 months of regular service, Executive Assistants (EAs) / Stenographer Grade-I who have rendered minimum combined regular service of 07 years and 06 months in EA/TA grade and Stenographers Gr-I / Stenographers Gr-II grade with at least 02 years of regular service in Executive Assistant or Stenographer Gr-I respectively, as on 01.01.2026, and who have successfully passed the Departmental Qualifying Examination as on 01.01.2026 as per the Central Excise and Customs Commissionerates Inspector (Central Excise, Preventive Officer and Examiner), Group 'B' Posts Recruitment Rules, 2016 (herein after referred as 'Inspector RR, 2016') for consideration for promotion to the post of Inspector (Preventive Officer) for vacancy year 2026.
3. It is also pertinent to mention that the willing officers would be required to undergo and pass the physical tests and conform to the physical standards prescribed for direct recruits under column (7) of Inspector RR, 2016.
4. It may be noted that the applications/willingness received in response to this particular circular will only be considered for the above said post. All earlier willingness submitted to the department will not be considered for the promotion to the grade of Inspector (Preventive Officer). The candidates offering their willingness for the post of Inspector (Preventive Officer) will not be permitted to withdraw their willingness under any circumstances.
5. The willingness for the promotion to the grade of Inspector (Preventive Officer) should reach the undersigned on or before 27.02.2026 through hard copy submission or through e-mail at p.estt-mum-cus-zone1@gov.in. Willingness applications received after the aforesaid cut-off date will not be considered. Promotion secured on the basis of false

information furnished in the application is liable to be terminated forthwith, apart from any disciplinary action that might be taken against the individual including dismissal from service.

6. This willingness is being called purely as a preparatory work and is subject to approval of the One Time Relaxation by UPSC and competent authority, which is still under process.

7. All Supervisory Heads are requested to bring this Circular to the notice of all concerned.
