





The information sought by the applicant cannot be provided by this section due to the following reasons:


This office is not bound to maintain and is not maintaining any separate register or records of officers whose salary has been stepped up in the past. Further, the names of officers cannot even otherwise be provided as per the decision dated 13.11.2020 of Hon'ble Supreme Court of India para no.59 of Civil appeal no.10044 of 2010 titled as CPIO Supreme Court of India Vs Subhash Chandra Agrawal which states as :

"Reading of the aforesaid judicial precedents, in our opinion, would indicate that persons records, including name, address, physical, mental and psychological status, marks obtained, grades and answer sheet all are treated as personal information. Similarity, professional records including qualification, Performance, evaluation reports, ACRs, disciplinary proceedings etc, are all personal information, Medical records, treatment, choice of medicine, list of hospitals and doctors visited, findings recorded including that of the family members, information relating to assets, liabilities, Income tax return, details of Investments, lending and borrowing. etc, are personal information. Such personal information is entitled to protection from unwarranted invasion of privacy and conditional access is available when stipulation of larger public interests satisfied."
