5. Who is the Cadre Controlling Authority (Designation with office address) for the Post of Superintendent of Customs in the Mumbai Customs? Please provide supporting documents.

6. Who is the chairman (Designation) for the DPC for the (Designation with office address) for the Post of Superintendent of Customs in the Mumbai Customs? Please provide supporting documents.

Point No. 4: There is no direct recruitment of Superintendent (P), 100% vacancies to be filled by promotion. (Reference- Recruitment Rules, 2019 of Superintendent (P) notified vide GSR 340 dated 13.11.2019. (Copy enclosed).

Point No. 5: Jurisdictional Chief Commissioner of Customs (Reference- Board Letter dated 16.01.2003, issued vide F. No. A-11013/04/2002-Ad. IV) (Copy enclosed).

Point No. 6: Jurisdictional Chief Commissioner of Customs or Central Goods and Service Tax (Reference- Recruitment Rules, 2019 of Superintendent (P) notified vide GSR 340 dated 13.11.2019) (Copy enclosed).”

GROUND OF APPEAL: - The above reply is appealed to the appellate authority on the below mentioned grounds: -

(1) That, the RTI reply was partial did not disclosed the office address of the authority which was requested to provide in all the 6 points.

(2) That, the copy of Board Order dated 22.12.2019 is not legible. (Point No.1 of reply dated 02.06.2025)

(3) In point 1 replied **Commissioner**.

It was not provided that which Commissioner that is General, Import, Export etc. The information is not complete in terms with the exact designation with office address.

(4) In RTI application it was requested to provide office address of the Appointing Authority for the Post of Preventive Officer in the **Mumbai Customs**.

The office address of the Appointing Authority for the Post of Preventive Officer in the **Mumbai Customs** is not provided. (Point No.1 of reply dated 02.06.2025)

(5) In RTI application it was requested to provide office address of the Cadre Controlling Authority for the Post of Preventive Officer in the **Mumbai Customs**.

The office address of the Cadre Controlling Authority for the Post of Preventive Officer in the **Mumbai Customs** is not provided. (Point no.2 of reply dated 02.06.2025)

(6) In RTI application it was requested to provide office address of the chairman of the DPC for the Post of Preventive Officer in the **Mumbai Customs**.

The office address of the chairman of the DPC for the Post of Preventive Officer in the **Mumbai Customs** is not provided. (Point No. 3 of reply dated 02.06.2025)

(7) In RTI application it was requested to provide office address of the Cadre Controlling Authority for the Post of Superintendent of Customs (Preventive) in the **Mumbai Customs**.

The office address of the Cadre Controlling Authority for the Post of Superintendent of Customs (Preventive) in the **Mumbai Customs** is not provided. (Point no. 5 of reply dated 02.06.2025)

(8) In RTI application it was requested to provide office address of the chairman of the DPC for the Post of Superintendent of Customs (Preventive) in the **Mumbai Customs**.

The office address of the chairman of the DPC for the Post of Superintendent of Customs (Preventive) in the **Mumbai Customs** is not provided. (Point No. 6 of reply dated 02.06.2025)

In view of the above, it is requested to provide below mentioned information under RTI Act, 2005 which was requested vide RTI application registration No. CCUM1/R/E/25/ 00073.


1. Provide legible Copy of Board Order dated 22.12.2019.

Subject: - Online Appeal Reg. No. CCUM1/A/E/25/00006 dated 17.06.2025 filed by Shri Shylender Kumar Singh under Section 19(1) of the Right to Information Act, 2005 against CPIO's reply dated 02.06.2025 in respect of RTI application reg. no. CCUM1/R/E/25/00073 dated 05.05.2025 issued vide F. No. GEN/RTI/194/2025.

BRIEF FACTS OF THE CASE

This is an order passed in the case of an online Appeal Reg. No. CCUM1/A/E/25/00006 dated 17.06.2025 received on 19.06.2025, filed by Shri Shylender Kumar Singh (herein referred to as the Appellant) against the Central Public Information Officer's the order CPIO's reply dated 02.06.2025 in respect of RTI application reg. no. CCUM1/R/E/25/00073 dated 05.05.2025 issued vide F. No. GEN/RTI/194/2025.

2. Brief fact of the case is that the Appellant residing at A-702, Kendriya GST Parisar, Sector-7, Kharghar, Navi Mumbai, Maharashtra-410210 had sought following information under the Right to information Act, 2005 vide his RTI application CCUM1/R/E/25/00073 dated 05.05.2025, in brief the same is reproduced as under:

The Joint Commisioiner of Customs (in-situ) P&E, NCH, Mumbai vide Circular No. 21/2025 dated 28.04.2025 published Final Common Seniority List of Superintendent (P) of Mumbai and Goa Customs for the period 2018 to 2025.

I Shylender Kumar Singh, seeking information under RTI Act, 2005.

- i) Who is appointing authority (Designation with officer address) for the post of Preventive Officer in the Mumbai Customs? Please provide supporting documents.
- ii) Who is Cadre Controlling Authority (Designation with officer address) for the post of Preventive Officer in the Mumbai Customs? Please provide supporting documents.
- iii) Who is the chairman (Designation with office address) for the DPC for the post of Preventive Officer in the Mumbai Customs? Please provide supporting documents.
- iv) Who is appointing authority (Designation with office address) for the Post of Superintendent of Customs in the Mumbai Customs? Please provide supporting documents.

- v) Who is the Cadre Controlling Authority (Designation with office address) for the Post of Superintendent of Customs in the Mumbai Customs? Please provide supporting documents.
- vi) Who is the chairman (Designation) for the DPC for the (Designation with office address) for the Post of Superintendent of Customs in the Mumbai Customs? Please provide supporting documents.

3. In response, the CPIO/RTI (General), NCH, Mumbai sought reply from concerned section. Accordingly, on the basis of information received from concerned Section, the reply was sent to the applicant vide letter dated 02.06.2025 (F. No. GEN/RTI/194/2025).

GROUND OF APPEAL

4. The appellant filed an online appeal bearing reg. no. CCUM1/A/E/25/00006 dated 17.06.2025 against the online RTI application CCUM1/R/E/25/00073 dated 05.05.2025. The appeal is filed on the following grounds:

Provided incomplete, misleading or false information.

- 4.1 The RTI reply was partial did not disclosed the office address of the authority which was requested to provide in all the 6 points.
- 4.2 That, the copy of Board Order dated 22.12.2019 is not legible (point no 1 of reply dated 02.06.2025).
- 4.3 In point 1 replied Commissioner. It was not provided the which Commissioner that is General, Import, Export etc, the information is not complete in terms with the exact designation with office address.
- 4.4 The office address of the Appointing Authority for the Post of Preventive Officer in the Mumbai Customs is not provided. (point No.1 of reply dated 02.06.2025).
- 4.5 The office address of the Cadre Controlling Authority for the post of Preventive Officer in the Mumbai Customs is not Provided. (Point No. 2 of reply dated 02.06.2025).
- 4.6 The office address of the chairman of the DPC for the Post of Preventive Officer in the Mumbai Customs is not provided. (Point No.3 of reply dated 02.06.2025).

- 4.7** The office address of the Cadre Controlling Authority for the Post of Superintendent of Customs (P) in the Mumbai Customs is not provided. (Point No.5 of reply dated 02.06.2025).
- 4.8** The office address of the chairman of the DPC for the Post of Superintendent of Customs (P) in the Mumbai Customs is not provided. (Point No. 6 of reply dated 02.06.2025).

PERSONAL HEARING

5. In this matter, three online hearings scheduled for 01.07.2025, 03.07.2025, and 07.07.2025 at 11:30 AM, were granted to the appellant and duly communicated to him. However, the appellant failed to attend any of the hearings.

DISCUSSION AND FINDINGS

6. I have gone through the RTI application CCUM1/R/E/25/00073 dated 05.05.2025, CPIO's reply dated 02.06.2025, online appeal dated 17.06.2025 received on 19.06.2025 and other relevant documents available on records.

6.1 That the Appellant vide RTI application dated 05.05.2025 sought the information as mentioned in para 2 above.

6.2 That the CPIO vide letter F. No. GEN/RTI/194/2025 dated 02.06.2025 replied to the Appellant as mentioned in para 3 above.

6.3 That aggrieved by the said CPIO reply, the Appellant filed the subject appeal on the grounds as mentioned in para 4 above.

6.4 That the appellant, through his RTI application, requested information regarding the designation and office addresses of the Appointing Authority, Cadre Controlling Authority, and Chairman of the Departmental Promotion Committee (DPC) for the posts of Preventive Officer and Superintendent (P) in Mumbai Customs. However, the Central Public Information Officer (CPIO), in a response dated 02.06.2025, provided only the designations of the aforementioned authorities, without furnishing their office addresses.

6.5 In light of the above, it appears that the information provided to the appellant is incomplete. Therefore, I am of the considered opinion that complete information, including the official addresses of the concerned authorities, should be provided to the appellant in response to his RTI application.

ORDER

7. In view of above discussion and findings, I pass the following order, as per the provisions of the RTI ACT, 2005.

7.1 The CPIO is directed to provide the complete information sought in the RTI application and appeal within Fifteen days from the date of receipt of this order.

7.3 The appeal is disposed of accordingly.
