CCUM1/R/X/25/00012 dated 09.06.2025 issued vide F. No. GEN/RTI/238/2025.

#### BRIEF FACTS OF THE CASE

This is an order passed in the case of an online Appeal Reg. No. CCUM1/A/E/25/00009 dated 14.07.2025 received on 16.07.2025, filed by Miss. Prerna Chauhan (herein referred to as the Appellant) against the Central Public Information Officer's the order CPIO's reply dated 02.07.2025 in respect of RTI application reg. no. CCUM1/R/X/25/00012 dated 09.06.2025 issued vide F. No. GEN/RTI/238/2025.

2. Brief fact of the case is that the Appellant residing at RZ 19-B, Main Sagarpur, Gali No. 03, New Delhi-110046 had sought following information vide Point No. 2 under the Right to information Act, 2005 vide his RTI application CCUM1/R/X/25/00012 dated 09.06.2025, in brief the same is reproduced as under:

"Kindly provide the office wise vacancies of the Mumbai Zone (Customs and CGST) bifurcated according to the category for both Grade C and D of SSC Stenographer Exam, 2024."

**3.** In response, the CPIO/RTI (General), NCH, Mumbai sought reply from concerned section. Accordingly, on the basis of information received from concerned Section, the reply sent to the applicant vide letter dated 02.06.2025 (F. No. GEN/RTI/194/2025) in brief the same is reproduced as under:

It is submitted that as per available records, NIL vacancies were reported in respect of Stenographer Grade C (Stenographer Grade-I) and Stenographer Grade D (Stenographer Grade-II) for SSC Stenographer Exam, 2024.

## **GROUNDS OF APPEAL**

**4.** The appellant filed an online appeal bearing reg. no. CCUM1/A/E/25/00009 dated 14.07.2025 against the online RTI application CCUM1/R/X/25/00012 dated 09.06.2025 The appeal is filed on the following grounds:

Provided incomplete, misleading or false information.

This is regarding getting clarification on the change in the number of vacancies for SSC Stenographer Grade C and D, 2024 which earlier in one of the replies of RTI was provided as 3 and 4 respectively for the Un-reserved category (Feb, 2025), but later in other reply of RTI it was stated as NIL (July, 2025). Also, the same information was provided from the CBEC wherein they mentioned that there are vacancies in the Mumbai Customs in both the grades (July, 2025). This mismatch in the information is quite misleading which might lead to wrongful selection of the state preferences for the upcoming recruits.

#### PERSONAL HEARING

5. In this matter, online hearing which was scheduled for 24.07.2025 at 11:30 AM, granted to the appellant and duly communicated to him. The appellant attended the personal hearing held in online mode and explained the grounds of her appeal.

## DISCUSSION AND FINDINGS

- 6. I have gone through the RTI application CCUM1/R/X/25/00012 dated 09.06.2025, CPIO's reply dated 02.07.2025, online appeal dated 14.07.2025 received on 16.07.2025 and other relevant documents available on records and find:
- **6.1** That the Appellant vide RTI application dated 09.06.2025 sought the information as mentioned in para 2 above.
- **6.2** That the CPIO vide letter F. No. GEN/RTI/238/2025 dated 02.072025 replied to the Appellant as mentioned in para 3 above.
- **6.3** That aggrieved by the said CPIO reply, the Appellant filed the subject appeal dated 14.07.2025 on the grounds as mentioned in para 4 above.
- 6.4 That the appellant has sought clarification regarding discrepancies in the replies to RTI applications dated 04.02.2025 and 02.07.2025 filed by two different applicants, pertaining to the category-wise vacancies of Stenographer Grade C and D reported to the SSC for the Stenographer Examination, 2024, from Mumbai Customs. Upon perusal of the aforementioned replies and the available records, it is observed that there is a mismatch in the information provided regarding the vacancies reported to the SSC by Mumbai Customs for the said examination.
- **6.5** In light of the above, I am of the considered opinion that correct and complete information, should be provided to the appellant in response to his RTI application.

### ORDER

- **7.** In view of above discussion and findings, I pass the following order, as per the provisions of the RTI ACT, 2005.
- 7.1 The CPIO is directed to provide the correct and complete information sought in the RTI application within Fifteen days from the date of receipt of this order.
- **7.2** The appeal is disposed of accordingly.

Accordingly, as directed by the FAA the reply is as under:

It has come to knowledge that the vacancies for SSC Stenographer Grade C and D, 2024 were reported on two occasions by this office. In the first instance, the number of vacancies reported were NIL for both the cadres. Letter dated 14.02.2023 may kindly be referred in this regard (copy enclosed).

While in the later instance, updated number of vacancies were reported for SSC Stenographer Grade C, 2024 and SSC Stenographer Grade D. 2024 as under:

These are uploaded on e-Vacancy module of DGHRD and can be accessed with the tabs named "Stenographer-II 2025/ Stenographer-II 2024S" and "Stenographer-1 2024S" under the heading Vacancies.

With regard to the RTI reply dated 02.07.2025, reference was taken from letter dated 14.02.2023 (wherein the vacancy position was NIL for both Cadres).

While regarding the RTI dated 04.02.2025, reference was taken from the e-Vacancy module of DGHRD for the updated data. The information as provided by Central Board of Excise and Customs. Customs (submitted by the applicant in her Appeal) also matches with the data as provided by earlier RTI Reply dated 04.02.2025.

Hence, it is evident that the RTI reply dated 02.07.2025 was not based on the updated data whereas the RTI reply dated 04.02.2025 was based on the updated data.

In view of the above it is clarified that the number of vacancies mentioned by Central Board of Excise and Customs, Customs will be considered for the recruitment of the SSC Stenographer Grade C and D for the year 2024 as they are based on the updated data on e-Vacancy module of DGHRD as provided by this office.
