Notification No. 03/2023-24-CUS(G)

Sub: (i) Revocation of notification of appointment of M/s Container Corporation of India Ltd. (CONCOR) as the Custodian of ICD Mulund under Section 45(1) & Section 141(2) of Customs Act, 1962;

(ii) Revocation of notification of appointment of M/s Container Corporation of India Ltd. (CONCOR) as the Customs Cargo Service Provider under Regulation 11(1) of “Regulations of Handling of cargo in Customs Area Regulations, 2009 – reg.


1. M/s Container Corporation of India Ltd (a Public Sector Undertaking) were earlier appointed as a Custodian of Container Freight Station, Mulund (East) under Section 45 of the Customs Act 1962, Notification issued from File No. S/19-Misc.45/Docks dated 09.11.1995 and Notification issued from File No. S/26/-Misc-290/2001/CFS(M)(I) Part-I.
2. The said 1,05,100 Sq. Mtrs of land was declared as Customs area vide notification no 01/2010 – CUS(G) issued from File No. S/23-Tech-105/2010 dated 15.03.2010, as a place for unloading of Imported goods and loading of export goods. The boundaries of the said area were notified as below;

On the East – Salt Commissioner Land.
On the West – Central Railway Mulund Goods shed.
On the North – Adjoining the C. Rly. Entry to goods shed.
On the South – Goregaon Link Road.
3. Thereon, CBEC appointed Mulund (Mumbai) as **Inland Container Depot** under Section 7 of The Customs Act, 1962 vide Notification No. 177/2009-CUSTOMS (N.T.) dated 11.12.2009 by inserting the name Mulund (Mumbai) against serial number 9, relating to the State of Maharashtra in the principle Notification No. 12/97-Customs (N.T.) dated 02.04.1997 [G.S.R. No. 193E dated 12.04.1997].
4. In pursuance of the Board Notification No. 177/2009 dated 11.12.2009 the total 1,05,100 Sq. Mtrs (96,000+9,100) of land was declared as Customs area vide Notification No. 01/2010 – CUS(G) issued from File No S/23-Tech-105/2010 dated 15.03.2010, as a place for unloading of Imported goods and loading of export goods. The boundaries of the said area were notified as below;

- On the East - Salt Commissioner Land.
On the West - Central Railway Mulund Goods shed.
On the North - Adjoining the C. Rly. Entry to goods shed.
On the South - Goregaon Link Road.

5. Under Regulation 10(1) of 'Handling of Cargo in Customs Area Regulations 2009' M/s. CONCOR was reappointed as the Custodian of Inland Container Depot, Mulund (East) Vide Notification No. 03/2010 CUS(G) issued from File No. S/26-Misc-07/2009 CFS (M)(I) dated 17.03.2010.
6. Vide Notification No. 07/2014-15 - CUS(G) dated 16.03.2015 issued from F. No. S/26-Misc-209/2014-15 ICD (M)(I) and Vide Notification No. 01/2019-20 - CUS(G) F. No. S/6-B-Misc-224/2010-11 ICD (M)(X) dated 13.03.2020, this office reappointed M/s Container Corporation of India Ltd. as the Custodian of ICD Mulund under Section 45(1) & Section 141(2) of CA, 1962 and approved the renewal of M/s Container Corporation of India Ltd. as Customs Cargo Service Provider under Regulation 13 of "Regulations of Handling of cargo in Customs Area Regulations, 2009" for a periods of further 5 years.
7. Now, in the light of the request made by M/s Container Corporation of India Ltd., I, Sunil Jain, Pr. Commissioner of Customs (General), Mumbai, vide powers conferred upon me under the provisions of Section 45(1) of The Customs Act, 1962, read with Regulation 11 (1) of "Handling of Cargo in Customs Area Regulations-2009", hereby revoke the Notification No. 03/2010 CUS(G) issued from File No. S/26-Misc-07/2009 CFS (M)(I) dated 17.03.2010 and the renewal granted vide Notification No. 01/2019-20 - CUS(G) vide F. No. S/6-B-Misc-224/2010-11 ICD (M)(X) dated 13.03.2020 appointing M/s Container Corporation of India Ltd. (CONCOR) as the Custodian and Customs Cargo Service Provider of ICD Mulund with immediate effect.
