RESULT-NOTICE

Subject: - Declaration of Result of Computer Base Examination (CBE) for Recruitment to the Post of Canteen Attendant, 2025.

The Computer Based Examination (CBE) for recruitment to the post of **Canteen Attendant, 2025** was conducted by the Office of the Commissioner of Customs, Mumbai Customs Zone-I on **24.05.2026** at designated examination centers.

1. A total of 1,396 candidates appeared for the Computer Based Examination.
2. The Tentative Answer Key(s) along with the Candidates' Response Sheet(s) were uploaded on the official website of Mumbai Customs Zone-I from 20.07.2026 to 23.07.2026.
3. During evaluation of the Answer Key, it was observed that in case of **only one question out of 100, the question had two correct options**. The final Answer Key has been prepared accordingly. Candidates who selected **either of the two correct options** have been awarded **0.50 mark** for that question.
4. The result of the Computer Based Examination has been prepared on the basis of the Final Answer Key in accordance with the provisions of the Recruitment Notice and the applicable Recruitment Rules.
5. The category-wise break-up of vacancies is as under:

*Category-wise break-up of candidates provisionally shortlisted for Document Verification against the notified vacancies for the post of Canteen Attendant, Mumbai Customs Zone-I, along

with the cut-off marks of the last shortlisted candidate in each category, is given above. In cases where candidates have been shortlisted against horizontal reservation categories [i.e., PwBD and Ex-Servicemen], the cut-off marks of the last shortlisted candidate are reflected against the respective horizontal category and not against their corresponding vertical category [UR, EWS, OBC, SC and ST].

9. The candidature of all shortlisted candidates is purely provisional. Shortlisting in the Computer Based Examination does not confer any right to appointment. The candidature shall remain subject to verification of eligibility conditions, educational qualification, age, category, EWS status, Ex-Servicemen status, PwBD status, character and antecedents, medical fitness, and fulfilment of all other conditions prescribed in the Recruitment Notice and the applicable Recruitment Rules.

10. Candidates shortlisted for Document Verification shall be required to produce the original certificates/documents, along with two set of self-attested photocopies, in support of their claims relating to age, educational qualification, category, EWS status, Ex-Servicemen status, PwBD status and other eligibility conditions. Failure to produce the requisite documents or furnishing any false information/document shall render the candidature liable to cancellation.

11. Resolution of Tie Cases

In case where two or more candidates have secured equal aggregate marks in the Computer Based Examination, the inter-se merit has been determined by applying the following tie-breaking criteria in the order given below:

- (i) Candidate securing higher marks in the Numerical Aptitude Section.
- (ii) Candidate older in age;
- (iii) Alphabetical order of the names of the candidates.

12. Normalization of Marks

Since the Computer Based Examination was conducted in a single shift, normalization of marks has not been applied.

13. The schedule for Document Verification shall be uploaded separately on the official website of Mumbai Customs Zone-I. Shortlisted candidates are advised to regularly visit the website for further updates.

14. In addition to the candidates provisionally shortlisted for Document Verification, category-wise waitlisted candidates may also be called for Document Verification, if considered necessary by the Competent Authority. The inclusion of a candidate in the waitlist or participation in the Document Verification process shall not confer any right to appointment. In the event that any provisionally selected candidate does not appear for Document Verification, is found ineligible, declines the offer of appointment, or otherwise fails to complete the recruitment formalities, the vacancy so arising may be filled, subject to availability and administrative requirements, by recommending the next eligible candidate from the waitlist of the respective category in order of merit.

15. The candidature of all candidates shall remain subject to the outcome of any litigation or court case, if any, pending before any Court of Law or Tribunal.

16. While every care has been taken in preparing the result, the Office of the Commissioner of Customs, Mumbai Customs Zone-I reserves the right to rectify any inadvertent error, omission or typographical mistake detected at any stage of the recruitment process.
