**Detention / Notice** Under section 142(1)(a)(b) of the Custom Act,1962

Sub: Recovery of differential duty of Rs. 18,36,652 /- along with applicable interest from M/S Car Collective Online (IEC -AAAPN4857G)

M/S Car Collective Online (Proprietor Shri Kunal Narang) (IEC- AAAPN4857G ), 501, Narang Manor, Plot No. 96-B , 15th Road, Bandra West, Mumbai 400050 has failed to pay an amount of confirmed Demand of Rs. 18,36,652/-(Rupees Eighteen Lakh Thirty Six Thousand Six Hundred Fifty Two only) along with applicable interest in pursuance to Order-in-Original NO. 07/2022-23 dated
