#### [UNDER SECTION 142 OF THE CUSTOMS ACT, 1962]

M/s NUCHEM LIMITED, 20/6, MATHURA ROAD, FARIDABAD CITY, FARIDABAD-121001, has failed to pay an amount of Rs.16,61,015/- [(Differential Duty 19,01,177- ApprCSD 2,40,162] and Rs.6,00,000/- (Fine + Penalty) along with applicable interest towards liabilities confirmed vide Order in Original No. 88674/2022 dated 15.03.2022.

Now, therefore, in exercise of the power conferred by clause (a) of Sub-Section (1) of Section 142 of Customs Act, 1962, I, Assistant Commissioner of Customs, Chennai, require and request that the aforesaid customs duty along with interest, fine and penalty should be recovered from any money payable to M/s NUCHEM LIMITED, by all those officers of Customs and/or officers of Central Excise (who have also been designated as officers of the Customs) all over the Country. I, also further require and request in terms of clause (b) of sub-section (1) of Section 142 of Customs Act, 1962, that the amount mentioned above should also be recovered by detaining and selling any goods belonging to the aforesaid party/ person by the officers of Customs and officers of Central Excise (who have been designated as officers of Customs) all over India.
