2. Candidates shall produce all original documents along with Two set of self-attested photocopies in support of their educational qualifications, age, category, EWS/PwBD/Ex-Servicemen status (where applicable), identity proof and other relevant certificates, as prescribed in the Recruitment Notice.
3. In case there is any discrepancy in the name or particulars of the candidate appearing in different documents, the candidate shall produce appropriate supporting documents issued by the Competent Authority, failing which the candidature shall be liable to be rejected.
4. **Candidates who fail to appear for Document Verification on the scheduled date and time shall be treated as absent, and their candidature shall be cancelled. No further opportunity for Document Verification shall be provided, and no representation in this regard shall be entertained.**

5. If any information furnished by a candidate in the application form is found to be false, incorrect or inconsistent with the documents produced during Document Verification, or if the candidate is found ineligible at any stage of the recruitment process, his/her candidature shall be cancelled without any further notice.
6. The date, time and venue of Document Verification are **final**. No request for rescheduling or change of the date, time or venue shall be entertained under any circumstances.
7. Mere appearance in the Document Verification does not confer any right to appointment. The candidature of the candidates shall remain purely provisional and subject to verification of eligibility conditions, educational qualifications, age, category, character and antecedents, medical fitness and fulfilment of all other conditions prescribed in the Recruitment Notice.
8. No Travelling Allowance (TA) or Dearness Allowance (DA) shall be admissible for attending the Document Verification.
9. The decision of the Competent Authority in all matters relating to Document Verification, eligibility and selection shall be final and binding, and no correspondence in this regard shall be entertained.
