Further Corrigendum to the PUBLIC NOTICE NO: 17/2025-26
dated 10.07.2025

Sub:- Launch of New Customs Passes on the Customs Brokers Licensing Management System (CBLMS) online portal - reg.

Kind attention of stakeholders is invited to this office Public Notice no. 17/2025-26 dated 10.07.2025 regarding Launch of new Customs Passes on the CBLMS online portal and Corrigendums dated 11.08.2025 11.09.2025 and 10.10.2025 to the said Public Notice.

2. In this regard, further Corrigendum is hereby issued to the said Public Notice. Para 7 of the Public Notice No. 17/2025-26, which reads as below:

*"With the introduction of the aforesaid functionality, it is hereby informed that all Customs Passes without QR Code functionality will be treated as invalid w.e.f. **11/08/2025**. Further, as a trade facilitation method and since the QR Code Customs Passes can be scanned for verification, the Customs Brokers are allowed to electronically display their QR Code, Customs Passes on smartphones at the time of verification. The QR Code on the Customs Passes will be scanned and authenticated by the officers at the time of entry and verification at Customs Stations (including Docks, Customs Freight Stations, Inland Container Depot, Warehouses, etc.) within the jurisdiction of Mumbai Customs Zone I, II and III."*

May be read as below:

*"With the introduction of the aforesaid functionality, it is hereby informed that all Customs Passes without QR Code functionality will be treated as invalid w.e.f. **31/03/2026**. Further, as a trade facilitation method and since the QR Code Customs Passes can be scanned for verification, the Customs Brokers are allowed to electronically display their QR Code, Customs Passes on smartphones at the time of*

verification. The QR Code on the Customs Passes will be scanned and authenticated by the officers at the time of entry and verification at Customs Stations (including Docks, Customs Freight Stations, Inland Container Depot, Warehouses, etc.) within the jurisdiction of Mumbai Customs Zone I, II and III."

3. All other contents of the Public Notice 17/2025-26 dt. 10.07.2025 remain unchanged.
