## OFFICE ORDER NO. 21 /2023

Sub: Constitution of Complaints Committee for dealing with complaints of sexual harassment at work place for Mumbai Customs Zone-I-reg.

In pursuance to the guidelines laid down by the Hon'ble Supreme Court, for prevention of sexual harassment of women in work places, vide its Judgement in the case of Vishakha & Others Vs State of Rajasthan & Others (AIR 1997 SC 3011) and further instructions issued by the Ministry of Finance, Department of Revenue vide F No C-30013/20/98-Ad IVA dated 04.07.1999 and the "Code of Conduct" prepared by 'National Commission for Women', a Complaints Committee was constituted in Mumbai Customs Zone by the Chief Commissioner's Office, vide Office Order F No S/II-8(11)/CCO/99 dated 22.9.1999.
