In terms of Regulation 7(1) of CBLR, 2018 the above applicants from Mumbai Policy section who have passed the written as well as oral examination shall make a payment of a fee of Rupees five thousand only (Rs. 5,000/- only) within two months of the declaration of the results of the oral examination and inform the payment particulars to the Principal Commissioner or Commissioner of Customs referred to in regulation 4 (2) of CBLR, 2018. If the successful applicant fails to make the payment of the said fee within the stipulated period, the right to be granted a license to an applicant shall be forfeited.
