Detention Notice

Under section 142(1)(a)(b) of the Customs Act, 1962

Sub: Recovery of Drawback/RoDTEP amount of Rs. 1,52,771/- along with applicable interest and penalty of Rs. 15,000/- from M/s. Spacotech Equipments & Structural Pvt.Ltd (IEC No. 0399005951).

M/s. Spacotech Equipments & Structural Pvt.Ltd (IEC No. 0399005951) has failed to pay the drawback/RoDTEP amount of Rs. 1,52,771/- (Rupees One Lakhs Fifty-Two Thousand Seven Hundred Seventy-One only) along with applicable interest and penalty of Rs. 15,000/- (Rupees Fifteen Thousand only) in pursuance of O-I-O No. 37/SLK/DC/DRC/NCH/2024-25 dtd 11.07.2024.

Now, therefore, in exercise of the power conferred by clause (a) of Sub-section (1) of Section 142 of Customs Act, 1962, require and request that the aforesaid amount of Rs. 1,52,771/- along with applicable interest and penalty of Rs. 15,000/- should be deducted from any money payable to the aforesaid party by the officer of Customs and/or Officers of Central Excise/GST (who have also been designated as Officers of Customs) all over the Country. I also further require in terms of clause (b) of Sub-section (1) of Section 142 of Customs Act, 1962, that the said amount should also be recovered by detaining and selling any goods belonging to the aforesaid party M/s. Spacotech Equipments & Structural Pvt.Ltd (IEC No. 0399005951) 101/1, A-17, Addl. Ambarnath, Anand Nagar, MIDC, Ambarnath (E) Dist. Thane, Maharashtra- 421501, which are under the control of the Officers of Customs and/or Officers of Central Excise/GST.

An intimation regarding the recovery may be sent to the undersigned as soon as the amount is realized. The amount so recovered may be sent to the undersigned by Demand Draft in favour of "RBI A/c Commissioner of Customs, Mumbai Customs Zone - I".
