DETENTION NOTICE

Under Section 142(1)(a)(b) of the Customs Act, 1962

Sub.: Recovery of Duty/Fine/Penalty of Rs.82,48,570/- (Rupees eighty two lakhs forty eight thousand five hundred seventy only) (Duty forgone of Rs.46,36,070/- + Fine of Rs.43,00,000/- + Penalty of Rs.4,60,000/- = Rs.93,96,070/- less Rs.11,47,500/- B.G. encashed) is recoverable from M/s. Rikosh Fashions Pvt Ltd (IEC No.0305038001) -Reg.

M/s. Rikosh Fashions Pvt. Ltd., IEC No. 0305038001, 605, Business Classic, Chincholi Bandar Road, Malad (West), Mumbai 400064 have failed to pay an amount of **Duty of Rs.46,36,070/- & Penalty of Rs.4,60,000/- along with applicable interest and Fine of Rs.43,00,000/-** confirmed vide Order in Original No.01/2024-25 dated 26.06.2024.

Now, therefore, in exercise of the power conferred by clause (a) of Sub-Section (1) of Section 142 of the Customs Act, 1962, I, Asstt. Commissioner of Customs, ICD Mulund, Mumbai Zone-I require and request that the aforesaid amount along with interest, should be recovered from any money payable to M/s.Rikosh Fashions Pvt. Ltd., Mumbai by all those officers of the Customs and / or officers of Central Excise (who have also been designated as officers of Customs) all over the Country. I, also further require and request in terms of clause (b) of subsection (1) of Section 142 of Customs Act, 1962, that the amount mentioned above should also be recovered by detaining and selling any goods belonging to the aforesaid party/person M/s.Rikosh Fashions Pvt. Ltd., IEC No. 0305038001, 605, Business Classic, Chincholi Bandar Road, Malad (West), Mumbai 400064 by the officers of Customs & Officers of Central Excise (who have been designated as officers of Customs) all over India.
