Original Educational/Professional Certificates/ Degree and equivalence certificates for the candidates who have appeared in the written examination on the basis of the educational qualification obtained/passed from the institutes/universities other than Institutes or Universities recognised by the Government.
  - c. Two Stamp Size photographs.
  - d. Customs Pass/ Valid Photo Identity Proof issued by the Govt. Authority.

In case of any discrepancy, deficiency etc. noticed w.r.t. mandatory eligibility in terms of Regulation 5 of CBLR, 2018 including educational qualifications, the result of such candidates shall be treated as 'NULL & VOID'. In case the candidate fails to appear for the above mentioned Oral Examination on the given date and time, no further opportunity shall be granted regarding the same.
